IV. Understanding

• A temporary outdoor sale permit allows an existing business in Acme Township to operate an outdoor sale on a temporary basis.

- Each business is allowed a maximum of 30 days of temporary outdoor sales per calendar year, including setup and take-down, and may not exceed three (3) temporary outdoor sales events per calendar year.
- Each temporary sale event must be applied for separately and is not to be considered as a reoccurring event.
- The approval of a temporary outdoor sale permit creates no vested right in the permittee to additional permits or to additional approvals. Acme Township may revise or revoke its temporary outdoor sale ordinance at any time and for any reason it determines appropriate. No temporary outdoor sale permit can create a non-conforming use for any permitee.
- An existing business must operate a temporary sale without the use of outside or third-party vendors, and the goods and products offered for sale must be an extension of the inventory within the established business.
- Temporary signage associated with a temporary outdoor sales event must not exceed sixteen (16) square feet and must meet the standards of §§7.4 and 7.2.10 of the Acme Township Zoning Ordinance.
- A temporary outdoor sale permit may be revoked at any time by the Acme Township Planner or Zoning Administrator in the event of activities not authorized by this permit or which are prohibited by the Acme Township Zoning Ordinance, local, state or federal laws.
